- 3. 3.Inspection book is not kept. This is breach of Sec. 18 R/W Rule 28
- 4. The exact wages for overtime work at the double of normal rate of wages are not being paid to the workers. This is breath of Sec. 14(1) R/W Rule 26(1)
- 5. Some /all workers are being paid wages less than the prescribed Minimum Wages. This is bleach of Sec 12(1)

- 9. The employer has making false entry in the records. This is breach of Rule 31(A) (II)
- 10. Weekly off is not provided to the worker. This is breach of Rule 23.
- 11. The employer has released wages in cash mode. This is breach of Sec 11(1).

The employer is asked to rectify the above mention irregularities and compliance shall be submitted to the undersigned within seven days from the receipt of these remarks. <u>If you fait to do so</u> the appropriate legal action can be taken under the said act.
